Dear Mr. Paglia:

Essex County has lost multiple submissions of my bank statements, social security number and other private data. My requests since September have been ignored. The lack of response to this dangerous loss is reprehensible and a likely "tell". Please prove me wrong.

DECADES AS ESSEX COUNTY RESIDENT

I have been a proud resident of Essex County since 1983. Our County employees have done a very good job providing services to our residents, businesses and visitors. Members of your staff and a couple of employees at the Essex County Division of Family Assistance & Benefits have done an admirable job trying to find the bank statements and other private data that I sent to 18 Rector Street, Newark, NJ 07102-4512. The people whom I remember going above and beyond to help me include K. Latimer, Maria R. Nieves, Asmeret Ghebremicael, and Lucia Guarni, Deputy Director.

EXPLANATION SUGGESTS IDENTITY THEFT

It is difficult to believe that after signing for the first package, and trying to find it since the second day received, that my requests were ignored and someone returned such sensitive data via regular U.S. Mail. I do not believe this happened twice. So I escalated my request and asked what happened to the second package that was signed for 30 days later. I still have not received a response.

Essex County has mitigated serious problems. This is the most expensive, impacting problem that has not been addressed. Several documents that I have sent to resolve this, and have been acknowledged as received, are listed in Attachment I. Digital copies of these documents are available upon request. Copies of two documents (#3 & #16) are enclosed.

PLEASE RETURN PRIVATE DATA

I trust this has been an oversight due to staff changes, because ignoring this mishandling of private information will not cause the problem to fade away. I hope that your office will find the information so that I will not have to escalate this further.

I expect that Essex County will return my bank statements (app. 250 pages), private documents and thumb drives with a plausible and detailed explanation.
