Chair FINRA Arbitration Hearing	March 5 – 8, 2019



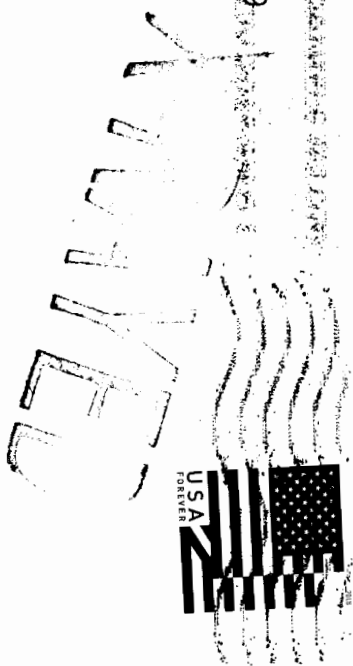
